### Superintendent's Report

## Superintendent Verdugo highlighted a variety of items:

- Superintendent Verdugo attended Lincoln School's Holiday program.
- Dr. Verdugo met with K-12 administrators and Cabinet members to address school sites safety precautions, practices, and drills in the aftermath of the Newtown, Sandy Hook Elementary school tragedy. In addition, a meeting has been scheduled with our local police and fire department as well as various District representatives at Paramount High School.
- Superintendent Verdugo announced that the District received news from the California Department of Education that Frank J. Zamboni has been selected as a "Schools to Watch" school.
- Dr. Verdugo shared with the Board that today, news was received that Alondra Middle School has been awarded the Mr. Hollands Opus Music Foundation award. This award was given to Alondra Middle School for their outstanding dedication to helping their music program and students achieve their greatest potential.

## K-12 Instructional Technology Update

Mr. Manuel San Miguel, Director of Secondary & Alternative Education shared with the Board that the purpose of the presentation is to provide an update on the progress of K-12 instructional technology and to outline next steps and future work.

Current K-12 Instruction Technology projects include I-Pad deployment pilot, middle school technology electives and new computer labs at Alondra, Collins, Jackson, and Keppel school with three additional labs scheduled this year for Wirtz, Tanner and Paramount Park.

I-Pads are being deployed at Alondra Middle School to achieve the following objectives:

- Experience using I-Pads in the instructional program of two Science teachers at Alondra Middle School
- Learn what works and what does not work in the implementation of I-Pads grades 6-8
- Meet regularly to communicate strengths and challenges of I-Pad implementation

Three (3) Science teachers from Alondra Middle School attended a full day of professional development at the Los Angeles County Office of Education on the use of I-Pads in Science instruction. A full day of professional development and planning is scheduled for January 11, 2013 that will assist teachers in building I-Pad instruction into their Science pacing.

Middle School technology elective course outlines were revised to include:

National Education Technology and CTE standards

- Alignment with our current Career Technical Education (CTE) Pathways
- Benchmark assessments
- Safe and responsible use of technology and internet

The District's next steps include:

- Continue to monitor computer lab installations
- Continue to monitor and evaluate I-Pad pilot program
- Complete 6-8 elective benchmarks and evaluate pacing at end of year
- Develop project plan that will support the transition of students and staff to Common Core technology-based assessments.
