Employing the Foster Youth/Homeless Services Counselor during the summer will ensure students continue to receive appropriate services to meet their needs and to plan and prepare for the upcoming school year, as the needs of the student and their family continue year-round. This would allow for immediate outreach in assuring student identification for and connection to resources and services when a child moves into our area during the summer months. Students in foster care have an increase in residential change of placements after the close of the school year. Thus, there is a high level of fluctuation with incoming and outgoing students in foster care during the summer months. Continued collaboration with the Department of Children & Family Services during this time will provide assistance in easing transitions for students in foster care. This will allow for support for families during the summer months and will properly assist in preparing students for the new school year by ensuring that students have proper school supplies, uniforms, immunization referrals, housing assistance, hygiene supplies and dental and medical needs prior to the first day of school.

Staff is recommending a revised job description for Foster Youth/Homeless Services Counselor with an extended work year of 223 days.
