Leona Jackson School is located at 7220 East Jackson Street in Paramount in the southwest area of Paramount. Major streets that border the school are Garfield Avenue and Jackson Street. The parking lot is located on the west end of the campus. The school consists of an administration building with a library, four wings of classrooms, and a multi-purpose room. With an enrollment of approximately 650 students, our school serves a diverse population (77% Hispanic, 18% African American, and 5% Other Ethnicities). In addition, approximately 20% of our students are English Learners, with Spanish as their predominate language.

Where the most viable option, LEAs were required to administer the statewide summative assessment in ELA and mathematics. Where a statewide summative assessment was not the most viable option for the LEA (or for one or more grade-level[s] within the LEA) due to the pandemic, LEAs were allowed to report results from a different assessment that met the criteria established by the State Board of Education (SBE) on March 16, 2021. The assessments were required to be:

- Aligned with CA CCSS for ELA and mathematics;
- Available to students in grades 3 through 8, and grade 11; and
- Uniformly administered across a grade, grade span, school, or district to all eligible students.

Options

Note that the CAAs could only be administered in-person following health and safety requirements. If it was not viable for the LEA to administer the CAAs in person with health and safety guidelines in place, the LEA was directed to not administer the tests.
