## Superintendent's Report

Superintendent Mendez highlighted a variety of items:

- Superintendent Mendez along with Board of Education members attended the CSBA Annual Education Conference held in San Diego.
- He announced that Principals Lynn Butler-Alondra Middle School and Lisa Nunley-Macon-Jackson School received notification that they will be receiving visits by the School's To Watch program and advancing into the second phase of the process.
- Mr. Mendez wished everyone happy holidays and announced the District will be observing winter break beginning December 16 through January 3, 2014 with school resuming on January 6<sup>th</sup>.

## Bulletin Boards – Tanner School

Principal Patricia Brent-Sanco presented an overview of the Boardroom bulletin boards representing the Tanner School's educational program student work. The bulletin boards reflect the theme of "Tanner's Winter Learning Wonderland" and enhance the educational message sent to visitors and District office employees.

# Budget Update

Assistant Superintendent-Business Services, Dr. Michael Conroy provided the Board with a brief summary of the First Interim Budget that will be before the Board's approval further in the agenda.

Paramount Unified School District's Fiscal Stabilization Plan is guided by three principles: Advance Student Achievement, Ensure District Fiscal Solvency and Maintain Positive Labor Relations – all equally important.

The First Interim budget is based on 1) what fiscal information we know today and 2) guidance from Los Angeles County Office of Education.

Dr. Conroy shared the District's budget assumptions which include:

- \* LCFF Calculation
  - Multi Year Projections declining enrollment projection

- Status quo regarding student demographics
- \* Budget tentative agreements with employee associations for salary and health & welfare contribution increases
  - Total compensation package = 5.45 % increase
- \* Reduce deficit spending beginning in 2014-15
- \* Ending Fund Balance establishment of LCFF Reserve beginning in 2014-15

Dr. Conroy also shared some 2013-14 encroachment figures that total \$12,700,074. The JROTC program totals \$121,001, Continuation School-\$428,767, Routine Restricted Maintenance-\$3,667,990 and Special Education-\$8,482,316.

The District will be applying for deferral waiver and a mid-year TRANS.

The Department of Finance cited evidence that the State's economic conditions may be slowing. The Legislative Analyst's Office estimate that full implementation of the Local Control Funding Formula will take longer than originally planned. It is now expecting only about 90% implementation by 2020-21. Prop 30 Temporary taxes will expire in 2016.

Multi-Year considerations include:

- Additional LCFF reserve to protect against economic downturn
- CSR requirements
- Revenue changes due to fluctuations in:
  - \* projected deceleration of enrollment growth
  - \* student demographics changes
- COLA no longer determines subsequent year's increases
- There is no statutory calculation for how much the state will contribute and no obligation to fund at any certain amount
- Prop 30 Temporary Tax

# LCFF Volatility include:

- LCFF calculations are impacted by:
  - \*student enrollment fluctuations
  - \*targeted sub-group enrollment variations
  - \*uncertainties due to variances in economy
    - \* impacts the Base Grant calculations
