Regular Meeting Minutes August 13, 2014	The minutes of the August 13, 2014 were tabled for the next scheduled Board meeting on September 24, 2014.
<u>REPORTS</u>	
Employee Representative	There was no CSEA representative in attendance.
Reports	TAP President April O'Conner shared that the association is happy as bargaining for the new school year has begun and is happy to be in attendance on behalf of teachers who are hard workers. She is also happy to know that the District has hired about 60 teachers this school year. The District needs highly educated and motivated teachers here in Paramount. The District needs to compete with neighboring districts for the highly qualified teachers. The association is asking for an increase in salaries and an increase in the hourly teacher pay rate to help cover childcare expenses when teachers are working extra. Our teachers want their students to be successful. She added that Common Core brings a lot of stress to teachers and asks that prep time for the high school teachers be respected and asks that prep time be provided to middle school teachers as they need it as well. Testing schedules are stressful and prep time is important for that too. Teachers are looking forward to stabilizing and balancing their classes.

Superintendent's Report	 Superintendent Mendez highlighted a variety of items: Superintendent Mendez shared that he echoed the same sentiments as Board President Cuellar.

current direct instruction.

ST Math

- Is a visual, game-based math program
- Builds Conceptual Understanding & is aligned to the Common Core State Standards for Mathematics
- Kids solve interactive puzzles with JiJi the penguin
- Spatial Temporal Reasoning
 - The ability to form a mental image and manipulate it over a sequence of steps in space and time.

The Fundamental Theory of ST Math®:

- "All math problems have been reduced to:
 - How can I get a penguin to cross the screen?"

- The genesis of the Math Initiative was to help with improving API performance.

LCAP Update: College and Career Committee

Dr. Deborah Stark, Assistant Superintendent-Educational Services and Dr. Jose Iniguez, Director-Secondary Education provided the Board with an update on College and Career Committees for 2014-15. New initiatives will be supported by the work of four district committees:

- College and Career Committee
- Academic Intervention and Professional Period Committee
- Strategic Data Use Committee
- K-5 Achievement Report Committee

Dr. Stark shared that the presentation will provide an overview of two district committees, College and Career Committee and Academic Intervention and Professional Period Committee, it will outline the process that will be used for these two committees in 2014-15 and review next steps.

Dr. Iniguez added that a LCAP goal is to create a college going culture. PUSD's LCAP outlines the need to create a college going culture by implementing the following:

- Increase A-G course participation
- Increase the number of AP and CTE courses offered
- Increase number of students who score at 3 or higher on AP tests
- Improve student achievement on Early Assessment Program, SAT and ACT
- Expand College and Career Center at PHS, create College and Career Center at PHS-West
- Increase college going rate

Increase middle school electives that align with college readiness and CTE

College and Career Committee Goal is to develop recommendations for a two-year plan beginning in 2015-16 that includes actions, strategies and resources to increase college and career readiness. To meet this goal, the committee will review:

- PUSD's achievement data on college and career readiness
- Qualities of effective college going cultures for middle and high schools
- How course offerings in grades 6-12 can be expanded to prepare students for college and career without remediation
- How to increase the number of PUSD student who meet college admission criteria

LCAP Goal: Support Academic Progress:

PUSD's LCAP outlines the need to support academic progress by implementing the following:

 Improve academic performance of target students performing below grade level with mandatory academic interventions. Provide time for professional collaboration on best practices in instruction and assessment

Academic Interventions and Professional Period Committee

Goals for the Committee:

- 1. Learn about best practices for academic interventions in grades 6-9 and how they can be delivered during the school day.
- 2. Learn about effective practices for providing a "professional period" for middle school teachers.
- 3. To develop recommendations for 2015-16 that include:
- How schools will provide time for academic interventions.
- A focus for the professional period for grades 6-8.
- A structure for the professional period that supports the focus.

The District's next steps include:

- Implement activities outlined in timelines for both committees.
- Communicate progress to Board of Education, and school staffs through:
 - o Board updates
 - Newsletters describing committee progress sent to schools, posted on PUSD website

Budget Update

Dr. Michael Conroy, Assistant Superintendent-Business Services provided the Board with a Budget update and shared that the purpose of the presentation is to review and inform the Board on relevant State budget conditions that impact the District, and update the Board on the 2013-14 the Unaudited Actuals. Budget Topics:

- I. State budgetary issues (post PUSD Budget Adoption) Themes Revenue Forecasts Expenditures

- II. 2013-14 Unaudited Actuals Summary

Themes:

- Overall budget policy decisions continue to be reflective of slow but seemingly steady economic improvement
- State revenues surge for a variety of reasons, but:
 - The Department of Finance (DOF) lowers its forecast for 2015-16 Local Control Funding Formula (LCFF) funding levels significantly
 - The revenue volatility we have been concerned about is coming into play
 - There are no statutory or constitutional guarantees for future year Local Control Funding Formula (LCFF) funding levels

Competing State Revenue Forecasts:

- Like last year, the Governor's revenue forecast was lower than the forecast of the Legislative Analyst's Office (LAO), the Legislature's fiscal advisor
 - For 2013-14 and 2014-15 combined, the LAO forecast was \$2.8 billion in additional revenues
 - Both houses of the Legislature initially assumed the higher LAO forecast and augmented 2014-15 expenditures accordingly
 - Ultimately, however, the Budget Conference Committee adopted the Administration's revenue forecast and sent Governor Brown a Budget based largely on his May Revision expenditure plan
- Postscript to 2013-14 revenues in the end, the LAO's forecast was closer than the Administration's, with revenues coming in roughly \$5 billion more than budgeted

Expenditures – Where the Action is:

- While LCFF funding projections take a marked turn downward in 2015-16, expenditures shoot up
 - California State Teachers' Retirement System (CalSTRS) contributions go up for employers, employees, and the state beginning in 2014-15
 - But by far the biggest impact is on the employer contribution which will increase each year and represent a total increase of 4.33% by 2016-17, the third year of the multiyear projection
 - o Beginning in 2015-16, California Public Employees'

Retirement System (CalPERS) rates also rocket upward

- After six years of deficit spending and few salary increases, budget stress is still a major factor
 - Salary demands and poor understanding by stakeholders of the LCFF and LCAP can create pressure within districts
- CalSTRS Rate Increases May Revision
- In a significant departure from his stated plan in January, Governor Jerry Brown announced in May that he intended to fully fund CalSTRS-in about 30 years
 - Contribution rate increases were proposed as follows:
 - State rate increases 4.311% over three years
 - Employer rate increases from 8.25% to 19.1% over seven years
 - Employee rate increases from 8% to 10.25% over three years
- Education management stakeholders expressed concern that the increase was too much, too soon
- CalSTRS testified that it could not yet accommodate two different employee contribution rates (pre- and post- Public Employees' Pension Reform Act (PEPRA)
- As a result of this feedback, the Legislature proposed a smaller employer rate increase during the first three years and a uniform employee rate for 2014-15
- The final plan has a smaller employer contribution rate increase in 2014-15 and consistent increases up to final implementation
- Once the statutory rates are achieved, CalSTRS will have the authority to increase or decrease the employer and state contribution rates
- With assets totaling more than \$300 billion, CalPERS is the nation's largest public pension fund
- While not ideal, the CalPERS system is in a relatively strong funding position
 - Total Fund 69.6% funded (as of June 30, 2012)
 - Schools and community colleges 80.5% funded (as of June 30, 2013)
- CalPERS is able to stay ahead of the curve because the CalPERS Board has some authority to increase rates
- In February 2014, CalPERS adopted new demographic assumptions based on member longevity
 - As a result, employer and state contribution rates will increase
- With new assumptions, CalPERS aims to fully fund the system

 eliminating the unfunded liability in about 30 years
- The employer contribution to CalPERS is increasing from 11.442% in 2013-14 to 11.771% in 2014-15
 - "Classic" members continue to pay 7.00%
 - New members pay 6.00%, which may fluctuate from year to year based on the PEPRA requirement to pay

half the normal cost rate

Proposition 30 Taxes are Temporary:

- Proposition 30, approved by voters in November 2012, temporarily increased the state sales tax and income tax rates for high-income earners to address state revenue shortfalls stemming from the Great Recession
- The higher rates boosted revenues \$7.1 billion in 2013-14 and are forecasted to provide \$7.4 billion in 2014-15
- Unless extended by the voters, these higher taxes will expire as follows:
 - The 0.25% sales tax increase expires in 2016 (i.e., the 2016-17 fiscal year)
 - The personal income tax increase expires in 2018 (i.e., the 2018-19 fiscal year)

LCFF 2014-15 Funding Provisions:

- Combined with elimination of the 2013-14 gap, the new formula will be over one-third of the way to full implementation after the first two years
 - As always, keep in mind that the LCFF increases of individual LEAs can vary significantly from the average
 - Amounts actually received range from zero to just over 18%
- LCFF Calculation components
 - o Enrollment
 - Adjustments
 - Supplemental and Concentration grants

Base Grant Entitlement Calculation:

- 2014-15 Enrollment Projections
 - Enrollment differences from Budget Adoption in June to September enrollment counts
 - $\circ~$ Budget adjustments are made after October CBEDS and at 1 $^{\rm st}$ Interim
 - Comparison of Enrollment Projections 2013-14 to 2014-15
 - Enrollment differences from September 6, 2013 to September 5, 2014
 - Enrollment counts same day, one year apart
 - 2014-15 target entitlement calculation
 - Grade span per-pupil grants are increased for the 0.85%statutory cost-of-living adjustment (COLA) – unchanged from the May Revision

Grade Span Adjustment Additions:

- K-3 class-size reduction and
 - 9-12 Career-Technical Education (CTE)
 - CTE is unrestricted; class size GSA requires progress toward maximum site average enrollment of 24 students in K-3 classes
- Grade Span Adjustment Penalty:
 - The 10.4% K-3 GSA is provided on the condition that districts

make annual progress toward a maximum average class size in grades K-3 for each school site of no more than 24 students enrolled (or a collectively bargained alternative average)

- Failure to make adequate annual progress at <u>any</u> single school site results in the loss of the adjustment for <u>all</u> students in those grade levels at <u>all</u> sites districtwide
 - This requirement will be part of the independent audit beginning in this school year -- 2014-15

PUSD Supplemental and Concentration Grants:

• Supplemental and concentration grants are calculated based on the percentage of district enrollment accounted for by English learners (EL), free and reduced-price meal (FRPM) program eligible students, and foster youth

New Implications - 2015-16

- Increased ongoing spending and reduced one-time costs in 2014-15 limited Proposition 98 funds available in 2015-16 for LCFF implementation
 - As a result, revised 2015-16 gap closure estimate drops by 10 percentage points, from 30.39% to 20.68%
- Budgeting for the future is always uncertain especially when others have control over your revenues. What does that mean for PUSD?
 - Budget reduction and reduction in expenditure plan for 2015-16
 - 2015-16 LCAP will be adjusted down due to lower revenue projections
- 2014-15 Updated Budget Assumptions:
 - Projections for Fiscal Years 2013-14 through 2016-17

Why do Districts need Adequate Reserves?

- The State Board of Education is charged with establishing <u>minimum</u> reserve levels – and their recommendation is just that – the minimum
- All districts need to maintain additional reserves to protect against:
 - Economic downturns and state-level budget cuts (recent history)
 - Volatility in LCFF gap closure funding (2015-16 change)
 - Declining enrollment and loss of funding
 - o Unplanned expenses, for example, CalSTRS/CalPERS

cost increases

- o Carryover balances for schools and departments
- Cash shortages
- Other projected needs for additional one-time funding
- Layoffs and program reductions by providing lead time to make budget adjustments
- Adequate reserves are an essential part of local control

LCFF Revenues Present More Risk:

- LCFF funding levels have no predictable anchors in statute or in the State Constitution
 - Unlike Proposition 98, the annual LCFF contribution is at the discretion of the state legislature and governor
 - As a result, districts that plan and make long-term commitments based upon state projections are at risk if those projections are revised
 - Case-in-point -- the state recently reduced its planned gap funding increase for 2015-16 by 33%, from 30.39% to 20.68%
 - Districts (PUSD) must now reduce budget projections in 2015-16
- SSC and LACOE advise districts to be to hold one year's worth of planned LCFF increases in reserve over and above the 3% Reserve for Economic Uncertainties
- PUSD New Board Policy maintain reserves equal to at least 1 month's expenditures
