Overview of 6-8 Synergy Parent Portal and Student Vue Pilot

Laura Ramos, Student Information Systems Manager provided the Board with an update on the 6-8 Synergy Parent Portal and Student Vue Pilot and shared that the purpose of the presentation is to provide information on the use of ParentVUE at all middle schools, pilot of StudentVUE at one middle school and to provide information on the District's next steps.

What is the ParentVUE Portal? ParentVue Portal is part of the Synergy Student Information System. It provides parents secure access to their child's academic information including assignments, grades, attendance and school calendar. Parents can also send email messages and questions on their child's progress to teachers directly from ParentVue Portal.

What is the StudentVUE Portal? StudentVUE Portal is part of the Synergy Student Information System. It provides students secure access to their own academic information including assignments, grades, attendance and school calendar. Students can also send customized email messages and questions on their progress to their teachers directly from StudentVUE Portal.

A StudentVUE pilot at Alondra Middle School will involve 60 eighth grade students. Students will learn how to use StudentVUE to monitor their academic information including class events, class assignments, tests, and academic performance. Two teachers will participate in this pilot and students will have access only to their own academic information. The Pilot at Alondra Middle School will be monitored and assessed.

The District's next steps include to continue monitoring parent use at middle schools; share best practices that lead to increased usage. We will continue to increase awareness and usage of ParentVUE at all middle schools, provide principals monthly updates on ParentVUE activity and we will evaluate Alondra Middle School pilot progress to determine next steps for possible expansion.

2005 General Obligation Refunding Bond Series Refinance

Mr. Michael Ogburn, Senior Vice President with California Financial Services and Mr. Rich Calabro with Piper Jaffray provided the Board with information on an opportunity to reduce the 2005 General Obligation Bond payment to a lower percentage rate for the District and community.




