- Proposition 55 passed
 - Funding stability after 2018
- Fund Balance adjusted for excess State Aid received in prior year
 - Property tax adjustment of \$3.7M
- One-time mandated reimbursement
 - Expected funding receipts of \$3.1M

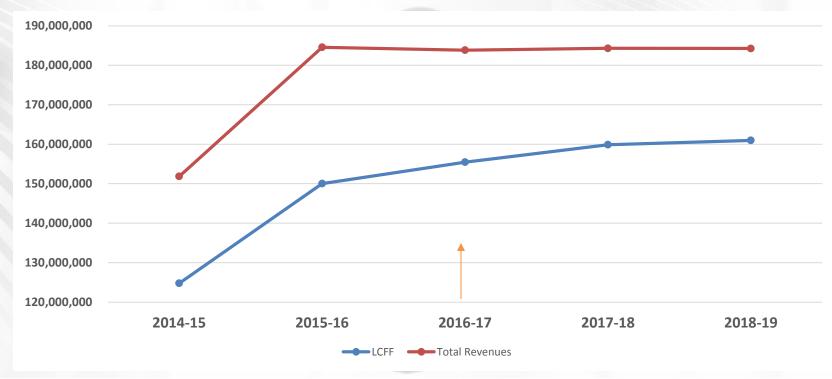
