2.1 Student Board Representatives

Janella Jimenez-Paramount High School, Marlene Ramos-Paramount High School-West, Mariana Sandoval-Buena Vista High School, Andres Salcedo-Odyssey STEM Academy and Carlos Gonzalez Paramount Adult School reported on various activities that have been taking place at their school sites.

2.2 Employee Representative Reports

Kim Goforth, TAP President shared that CTA and TAP visited all schools sites with one goal to gather signatures for an important initiative schools and communities first. The TAP bargaining team has been hard at work for a strong contract. She thanked Dr. Perez for the email updates on the coronavirus and on safety. She thanked Ruben Frutos for answering her calls and for the communication. She asked for everyone to remember why we are here.

Lourdes Aguayo address the board on behalf of CSEA and the Negotiations Team and shared that the Board has always been fair in negotiations as it pertains with salaries. CSEA is made up of loyal community members who take pride in their community and their work they put into being fair with contract and all they do. She addressed the step 6 that was negotiated four years ago. Members are still at 1.75% and step 6 is not complete. Why is step 6 being taken in increments that they have not seen and why do they have to take it as part of their salary increase. They understand that it cannot

all be done at once. They are at a point now where they want to know how it will be made whole and how is it going to happen and not be part of their salary increase as it has been in the works for some time now.

3. Public Hearing

Procedural: 3.1 Hearing Guidelines

During the hearing section, the following speakers addressed the Board Gerald Cerda, Brenda Nannette, Ms. Diaz:

Speaker Gerald Cerda addressed the Board regarding Measure Y and how will the money be spent, what is being done to eliminate fights, grant funds for air filters, concerns of the air in Paramount, and asked who is responsible for student if they all ill, the District or City and he shared with the Board of his illness diagnosis.

Speaker Brenda Nannette addressed the Board regarding the altercations at PHS West, asked that more cameras be implemented around campus and for more security to protect the kids. She shared about her visit to PHS-West to share what has been seen on Social Media, these incidents only happen at PHS-West during February and March during Black History month and she commented that Paramount is a good district.

Speaker Diaz addressed the Board to speak about parent concerns as it relates to the A.A.C. , the lost session that are not recovered, the worry that their children are not progressing, goals set in the children's I.E.P. are not being met, goals are the same year-to-year, the goals are too high and students are not able to meet them and that there is no permanent speech language therapist. She asked hocan parents know if they can get back the lost sessions and added that there does not seem to be consistency in the sessions that were recovered and asked what is the District policy on Special Education and sessions not provided. She appreciates the Board for their willingness to listen to the concerns of the community and she hopes that by bringing her concerns the Board will assist in improving the services and appropriate for their children.

4. Board Members/Superintendent Report

Board Member Gomez attended the meeting by Principal Mrs. Salcido for parents and students at West Campus regarding fights that happened on campus. She attended celebration Black Culture & Black Pride event in celebration of Black History Month and thanked Co-Advisors of Black Student Union Christine Barboza and Jeremy Mulcolan and the Black Union Executive Union for organizing event. She attended the LCAP meeting and referenced a robo call received on the LCAP meetign that was only in English and requested that all robo calls to be bilingual in English and Spanish. She requested for an alumni on how can donations be made to schools to assist with programs. She asked that questions from speakers be read once again at Board meetings as it has been shared with her that responses have not been read since January and February.

Board Member De Leon attended the event at Paramount West concerning Safety and said there needs to be collaborative discussions, she attended the Black Student Union event, the LCAP meeting and asked maybe we can bring motivational speakers and she would like to see follow up and follow through.

Board Member Garcia visited Lincoln school for the reading with Dr. Seuss. She shared that the Woman's Club has now for 21 years done the Woman's History Month and this year Collins school was selected to participate in the essay contest. She listened to the Odyssey podcast and encouraged everyone to listen to a podcast. She shared that the Odyssey students will be taking the AP test at PHS.

Vice President Cuarenta thanked PHS teachers for facilitating "We are more than just a color" she had a chance to be there and also thanked to Lena Gonzalez an Anthony Rendon for speaking to the students.

President Hansen attended State of the City Adrress and thanked Dr. Perez for providing an update on services provided to students. She attended The Lions Club speech contest and she thanked Christine Barboza for coaching the students. She attended the PHS parent coffee on a presentation on Social Media and hopes it can be provided to the other schools, the Special Ed parent workshop the parent forum at PHS West regarding the altercations that happened recently a timeline of events and steps staff is taking to ensure safety was presented, and she attended the CSBA workshop on the governor's budget and upcoming legislation that affect districts.

With these agreements, Compton College, UC Irvine, and the Paramount Unified School District have established a supported pathway for students to earn an Associates and Bachelor's degree upon graduation from high school.

There was discussion/questions on the following: a request for a pilot program (Gomez), make a policy for middle schools as they will go to the high school and know that they will not be allowed to use them (Gomez), was there a survey done on how many students are using cell phones in classes (Garcia), lunch time usage is the problem because of social media (Gomez), PHS-West pilot program to start in August with the new school year (Gomez), maintaining data if someone gets caught (Gomez), at the 21-22 school year we can try at Paramount High School (Gomez), issue was brought up by parents and they don't want them using cell phones (Hansen), policy can start next year (Hansen), policy will need to be in the handbook that goes out (Hansen), declining enrollment due to students transferring because of social media (Gomez), the request to have staff bring back a policy in April for first reading and second so that it is ready for the schools handbooks that go to parents (Hansen), disagreement if phones are taken away or locked up in pouches (Garcia), phones will not be locked up (Gomez), a suggestion to have information/data as back up to show that when they are not allowed to use them, academic increases and we've seen that in other schools (De Leon), teaching parents why cell phones are not a good choice (Cuarenta), data that shows there is less distractions, having the science behind us to prove it (De Leon).

President Hansen addressed issue on Augmentative and Alternative Communication Device that a parent stated students were not given services/devices and not given training and same thing came up tonight. The County Office of Education used to provide the trainings but now the Districts do and believes Dr. Garcia is in charge of that. President Hansen asked how many students use devices via the Wednesday report. President Hansen added that the parent who brought up this issue last time has received the training in October of last year and knows that they are trying to reschedule the training for her and her student and it's being taken care of.

Other questions she would like to provide answers for are:

- The number of classrooms being used for instruction in the District: 837
- The number of classrooms that have Merv 16 filters: 51
- The number of classrooms that have Merv 16 filters: 786

President Hansen shared a comment that was previously made that the District should always use the Department of Public Health when testing. President Hansen commented that we have always used them every time except once when they did not want to be involved and this is on the website.

President Hansen also responded to a comment from a speaker that he was dismayed and shocked that Bea Spelker was in a meeting with parents of students with special needs and that it was an intimidating and ethical violation of the Brown Act. Bea Spelker is not an elected official and none of the people in the room were elected officials. The Brown Act applies to elected officials, there can be no more of a majority of elected officials in a room without it being a public meeting. It was not a violation of the Brown Act.

A parent stated that the money is sitting in the bank which was brought up again tonight, the money is for the grant for filters. The money is not sitting in the bank, it is money that we will pay and get reimbursed for. The District has not received money from the grant.

President Hansen commented that earlier tonight, there was a question made on what the District was going to do with Measure Y money. President Hansen shared that Measure Y money is not the District's, it is goes to the City.

Vice President Cuarenta wished to follow up on the comment President Hansen made earlier on the parent and asked if the District followed up with the parent. President Hansen indicated that yes they did.

Board Member Garcia moved, Vice President Cuarenta seconded and the motion carried 5-0.
