The agenda for each Board of Education meeting is posted 72 hours in advance of each regular meeting and 24 hours before a special meeting. Closed Session may be conducted in accordance with applicable sections of California law.

On March 12, 2020, the Governor issued an Executive Order suspending parts of the Brown Act that included the following:

All requirements in... the Brown Act expressly or impliedly requiring the physical presence of members, the clerk or other personnel of the body, or of the public as a condition of participation in or quorum for a public meeting are hereby waived."

This means that Board Members may attend meetings remotely (i.e., by telephone or teleconference). Further, Board Meetings can proceed even if a quorum of the Board - or the entire Board - is participating remotely. This change also means that posting notices a the remote location and public access to the remote location are suspended, as well.

In compliance with the American with Disabilities Act, those requiring special assistance, to access written documents being discussed at the Board meeting, or to otherwise participate at Board meetings, please contact the Superintendent's Office at 562-602-6011 by 12:00 p.m., Wednesday, July 1, 2020 to enable the District to make reasonable arrangements.

BACKGROUND INFORMATION:

A Back to School Task Force of over 150 employees worked for 6 consecutive weeks to develop conceptual plans for a safe return to school plan for students and staff. Currently, there is a need to maintain social distancing of 6 feet between individuals due to the Corona Virus. This means that all students cannot come to school at the same time because a safe distance cannot be maintained. This necessitated alternative school schedules for the Task Force to develop to address less students in a classroom at one time and for students to study and have school from home. The Task Force identified two options: Blended Learning and Distance Learning. These options were developed with the concept that PUSD families would be provided the two options and be allowed to choose.
