On March 12, 2020, the Governor issued an Executive Order suspending parts of the Brown Act that included the following:

All requirements in... the Brown Act expressly or impliedly requiring the physical presence of members, the clerk or other personnel of the body, or of the public as a condition of participation in or quorum for a public meeting are hereby waived." This means that Board Members may attend meetings remotely (i.e., by telephone or teleconference). Further, Board Meetings can proceed even if a quorum of the Board - or the entire Board - is participating remotely. This change also means that posting notices at the remote location and public access to the remote location are suspended, as well.

In compliance with the American with Disabilities Act, those requiring special assistance, to access written documents being discussed at the Board meeting, or to otherwise participate at Board meetings, please contact the Superintendent's Office at 562-602-6011 by 12:00 p.m., Monday, July 27, 2020 to enable the District to make reasonable arrangements.

#### **BACKGROUND INFORMATION:**

Amidst the COVID-19 pandemic and in the face of rising infection rates in many parts of the state, on July 17, 2020, Governor Gavin Newsom addressed the conditions under which schools could reopen aligned to the California Department of Public Health directives issued the same day for reopening schools in the 2020-2021 school year. Stated in the Framework, a District cannot reopen for in-person instruction unless the county in which the District is located has been off the State's County Monitoring List for at least 14 consecutive days.
