## **BACKGROUND INFORMATION:**

Following the guidelines of the Los Angeles County Department of Public Health detailed in the Reopening Protocols for K-12 Schools, school districts can provide specialized services for defined subgroups of children who need in person services and support. The Superintendent will reconvene the Back to School Taskforce to develop a plan identifying eligible students to receive in-person instruction in the second semester of the 2020-2021 school year. As per the Department of Public Health's order the cohorts of students will be a stable group of no more than 12 children or youth and no more than two supervising adults for a maximum of 14 individuals who can be included in a cohort. Adults and children will stay together in all activities (e.g. meals, recreation, etc.) and avoid contact with people outside of their group in the setting. Additionally, as per the DPH Order the cohorts will not exceed 10% of each school's population.

## **BACKGROUND INFORMATION:**

Grades serve a valuable purpose by identifying students' areas of strength and need and helping students, parents and guardians understand the expectations for each grade level and course. In May, 2020 the District's grading policy was revised as the result of school closure due to the COVID-19 pandemic. After beginning the 2020-21 school-year in full distance learning, there is a need to provide a grading policy that holds students accountable for academic progress while assuring equity in light of the context of at home learning. The District's Back to School Task Force's elementary, middle and high school sub-groups, which included principals and teachers, discussed the topic of how to address grading in August. In addition, principals have discussed the attached recommendations with their site leadership teams for additional input. After extensive input, feedback and refinement the following revisions to grading are recommended for report cards, which includes trimester report cards for TK-5 and quarter/semester report cards for grades 6-12. These changes will be in effect during distance learning in the 2020-21 school year and will end in June, 2021.
