The Maintenance and Operations Department currently has a vacant Maintenance Carpenter/Glazier position. However, based on work orders and job assignments in Maintenance and Operations, an additional Maintenance Plumber is a higher priority over a Maintenance Carpenter/Glazier. Additionally, emergency work orders come through on a regular basis for the Maintenance Plumber as opposed to the Maintenance Carpenter/Glazier.

It is recommended that the vacant Maintenance Carpenter/Glazier position on the salary schedule L, range 134 (\$5,301-\$6,789) be eliminated and increased with an additional Maintenance Plumber position on salary schedule L, range 132 (\$5,047-\$6,460). The elimination of the Maintenance Carpenter/Glazier position will provide the District with an annual cost savings of \$5,355 and more appropriately meets the needs of the District.
